Lazada Intellectual Property Rights Protection Handbook

Lazada's Intellectual Property Protection Platform ("IPP Platform"), available at <u>https://ipp.alibabagroup.com</u>, is our industry-leading, one-stop online reporting system designed to make it easy to submit takedown requests for alleged infringement of intellectual property rights (IPR). The IPP Platform accepts takedown requests based on trademark, copyright and patent rights, and provides comprehensive information regarding takedown requests such as the status of the requests, success rate, and the success rate of counter-notices.

This Handbook provides step-by-step instructions for navigating the IPP Platform and submitting takedown requests regarding listings on our platforms. More information about the IPP Platform and our IPR policies may be found at: <u>http://ipp.alibabagroup.com/index.htm</u>

There are four basic steps to setting up an IPP account (note that Steps 1 and 2 are required only once, during the initial account setup process):

1) Provide a valid email address and phone number to register an IPP account. Choose the email address carefully as **it cannot be later changed**. Once the required information is provided and the terms of the IPP User Agreement are accepted (see below), a code will be sent to verify the email address.

2) Registrants outside of mainland China will upload documents to confirm their identity. Individuals may upload a digital image (e.g., a scan or photograph) of their official identity card such as a driver's license. For a business entity, such as a corporation, a digital image of the business license is required. Registrants in mainland China will choose from the verification options below under Step 2.

3) Continue the registration process by uploading digital images of original IPR documents into the IPP account such as currently valid patent, trademark or copyright registration certificates. Registrants should be sure to also upload any additional documents necessary to show that the submitted IPR is valid and owned by the registrant (e.g., assignments, renewals or extension documents).

4) Once the identification finished and *at least one* IPR document is uploaded, the IPP account will be reviewed and verified by Lazada. Once the account is verified, you will be able to submit takedown requests using the account. Be sure to actively monitor your account and respond to any requests from Lazada for additional information and/or counter-notifications.

Note: Each of the above steps is covered in greater detail below.

STEP 1: Register an IPP Platform Account with a Valid Email Address and a Phone Number

To submit takedown requests through the IPP Platform, rights holders or their authorized agents must first register an account on our IPP Platform. To do so, visit

<u>https://ipp.alibabagroup.com/index.htm</u> and click the "Register" hyperlink. (See the screenshot below, the ipp.alibabagroup.com home page.)



After clicking the "Register" link, registrants will see a series of fields that require input as a part of the account registration process: the registrant's "Location" (e.g., Mainland China, Other, etc.); "Identity category" (i.e., "Personal" or "Business" account); "Registrant category" (i.e., "Rights holder" or "Authorized agent"); "Email"; "Password"; etc. (See screenshot below.)

Once the required information has been provided, registrants will verify their information and click "Agree and register."

Note:

- For an account registered by an individual, the identification document may be your passport, driver's license, etc. For an account registered by a business entity, the identification document must be the business license.
- The email address you select when registering the IPP account will serve as your login ID and cannot be changed once the account has been created. Please select the email address carefully, and keep in mind that your company will need to be able to continue using the account, even in the event of personnel changes.
- Read the "IPP User Agreement" before checking the box at the bottom. Checking the box indicates agreement to the IPP User Agreement, which is necessary for creating an account. If you do not agree to the User Agreement you may submit takedown requests using one of the other NTD reporting channels Alibaba makes available.

After clicking "Agree and register," the registrant will be informed that a verification code has been sent by Alibaba to verify the designated email address for the account (see screenshot below). The verification code will need to be input by the account holder to proceed further.

STEP 2: Verifying Rights Holder Identity

2.1) Verifying Identity (International). Please note that Lazada requires documents to verify the identity of rights holders and their IPR. If you register as an entity or individual outside of Mainland China, you will be required to upload a digital image (e.g., a scan or photograph) of an official identity card such as a driver's license (for individuals) or a digital image of a business license (for a business entity). The identification documents and personal details remain confidential and will

not be disclosed to any other party without your prior consent.

"Agree and register."

2.2) Verifying Identity (Mainland China). Please note that if you registered as a Mainland China Individual, you will need to finish an additional verification step. You can use the Taobao App to conduct the True Person Authentication identity verification scanning process. Alternatively, you can conduct the identity verification by Individual Industrial and Commercial Household Verification (see screenshot below).

If you registered as a Mainland China enterprise, please finish the identity verification by using one of the three methods: corporate email, legal representative of the business entity or a corporate Alipay account (also see screenshot below).



Next, registrants are required to input contact information (see screenshot below). Please note that there are **two contact** information fields: 1) contact information that **will be disclosed** to merchants who are the subject of your takedown requests, and 2) contact information that will be used only by Alibaba to communicate with you, which will **not be disclosed** to merchants. Please ensure the contact information is valid, and accurately reflects the information you intend to share.

STEP 3: Verifying Rights Holder IPR

After successfully submitting the required information and uploading the identification documentation, rights holders will input information and provide documentation about the IPR they wish to enforce such as their trademark, copyright and/or patent registrations.

Under the "My IPR" tab (see screenshot below), select "IPR Submission" to provide the required information such as the type of IPR (e.g., trademark, copyright).

The information fields relevant to trademark registrations include information such as the trademark registration number, registrant information, class of goods, etc.

Once the necessary information has been provided, the registrant will upload (see screenshot below) a digital image of the IPR documentation, such as an image of the original registration certificate.



Once the necessary information has been provided and the documentation uploaded, you will submit the IPR for verification. To do so, click "Submit for verification" (see screenshot below). Lazada generally verifies IPR documentation and proof of identify within three working days.



Note:

- The IPR documentation can be a certificate bearing the seal of a relevant authority, such as a national patent or trademark office.
- If IPR has been renewed, or if ownership has been transferred or modified, to avoid delay please provide any such additional documents along with the original IPR certificate.
- To avoid delay, please note that the IPR documentation must clearly demonstrate that the IPR is successfully registered, currently in effect, and must match the identity of the rights holder in the IPP account.
- An agent authorized to act on behalf of rights holder is required to submit documentation, such as a power of attorney, demonstrating they're authorized to act on behalf of the rights holder.
- Please also note that it is important to separately complete and submit each IPR for verification.

After verification, the IPP account will be ready to use for takedown request submissions. Please note that IPP accounts will not be verified (and not active for takedown submissions) until the identifying documentation has been uploaded and at least one IPR document has been successfully uploaded.

To view the status of your IPR documentation verification, you may login to your IPP account and click the "IPR Management" tab on the left column (see screenshot below).

If, in the future, a rights holder or their authorized agent wants to add trademarks, copyrights or other IPR to the account, they may do so by following the above in this Step 3 (Steps 1 and 2 above will not need to again be completed).

STEP 4: Submitting and Managing Takedown Requests

Please note that takedown requests can be submitted through the IPP Platform only after the email address, rights holder and IPR have been verified, as outlined in the steps above. Once the account is verified and activated, the account may then be used to submit takedown requests based on the alleged infringement of IPR. To submit a takedown request, follow the steps below.

4.1) Submitting a Complaint

To request the removal of allegedly infringing listings, click the "Submit a complaint" tab (see screenshot below), and then select the corresponding platform (Lazada.com, Taobao.com, Tmall.com, Tmall Global, 1688.com, Alibaba.com or Aliexpress.com) on which you want to submit a takedown request.



- After selecting the platform, you will next need to:
 - From the "Sites" field (see screenshot below), choose the Lazada sites where the infringement listings located from the drop-down menu.
 - From the "IPR" field (see screenshot below), choose the type of IPR (trademark, copyright, etc.) allegedly infringed from the drop-down menu. Please note that you need a verified IPR before submitting complaints in particular countries.
 - From the adjacent drop-down menu (see below), choose from the IPR available in the account, which is to be used as the basis for the takedown request. Please note that this adjacent field is dynamic. For example, if you chose "Trademark" from the IPR field, the adjacent drop-down menu would display for your selection the verified trademarks available in your IPP account. If you chose "Copyright," the adjacent drop-down options would relate to the copyrights available in your IPP account, etc.
 - Select the "Complaint type," i.e., whether the claimed infringement is found in a "Product listing" or "Store front" (see arrow in screenshot below).

• You will also need to provide evidentiary information, or proof of infringement, to support the takedown request. Under "Proof of Infringement for the Complaint" (see screenshot below), you may input text into the "Supplemental infringement reason" field (see arrow in screenshot below) that describes the basis for the allegation. In other cases, such as allegations of counterfeit products, rights owners may elect to submit a separate document (e.g., uploading a comparison photo) to provide the required evidentiary information. Once the evidentiary information has been provided, click the "Submit" button to finalize your complaint submission.

4.3) Counter-Notifications

- Once your takedown request is processed, merchants may submit counter-notifications disputing the allegation of infringement. Please note, responses to counter-notifications are time-sensitive, and failure to respond in a timely manner will result in a merchant's counter-notification being deemed valid, the automatic withdrawal of your takedown request(s) and reinstatement of the listing(s).
- The email account used when registering the IPP account will receive a notification when the seller submits a counter-notification. However, we strongly encourage account holders to regularly check their IPP account and address any pending counter-notifications or other requested action.

4.3(a) Reviewing Counter-Notifications. To review counter-notifications, select "Manage Complaints" (see screenshot below, "Manage Complaints"), and select the corresponding platform.
